Core Basic Training Training

Core Basic Training: \$200.00

A Washington State Aging and Long-Term Support Administration (ALTSA); Department of Social and Health Services (DSHS) course:

Required by any Long Term Care (LTC) Worker providing care to clients in a, Assisted Living Facility, Adult Family Home, Group Home or (in certain cases) in a Home Health setting.

This course applies to Long Term Care (LTC) Workers in employment (in above mentioned facilities), who have not previously taken Revised Fundamentals of Caregiving Training. Core Basic Training is part of the 75 hours of LTC Worker Training required by Initiative 1163, adopted as of 01-07-12.

Core Basic Training is <u>NOT</u> for RN's, LPN's or Certified Nursing Assistants (NA-C's); or those who have <u>completed</u> those courses of study. These Licensed Caregivers are not subject to taking CBT, due to the Training that they have already received.

Important Information regarding Training Regulations / classes at this time:

The New Training requirements of Initiative 1163, which were brought to and passed by the voters in Nov., 2011, by the primary initiator of I-1029, Service Employees International Union (SEIU), are now in effect, <u>as of 01-07-12</u>. <u>I-1163 Training Requirements will NOT effect RN's, LPN's or NA-C's; except...</u> All LTC Workers (Long Term Care Worker) must take 12 Hours of Continuing Education (C.E.) per year. The C.E. requirement must be completed by ones Birthday (<u>not</u> the last day of the calendar year, December 31st, as in the past). <u>This requirement began on 07-01-12</u>. <u>Birthday to Birthday is the LTC Worker's "year"</u>.

Since 07-01-12, 12 Hours of C.E. must be completed by one's Birthday, or one cannot work until it IS done. See "Continuing Education Requirements" at this link:

Any LTC Worker hired <u>as of 01-07-12 or later</u>, <u>must</u> take 75 Hours of Long Term Care Worker Training; made up of: (1) Core Basic Training, (2) Population Specific Training, (3) Orientation Training and (4) Safety Training. Developmental Disabilities Training - Part 1: 8 Hours;

Developmental Disabilities Training - Part 2: 8 Hours;

Care of the Geriatric Resident Training: 6 Hours

Nurse Delegation Core Training; 9 Hours (if taken after 11-24-17)

Nurse Delegation; Special Focus on Diabetes Training: 3 Hours (if taken after 11-24-17)

Courses NOT INCLUDED in the 75 Hours of LTC Worker Training; but still probable Training requirements:

CPR Training: No longer being offered at this time.

First Aid Training: No longer being offered at this time.

HIV/AIDS Training (also included in CBT): 1.5 Hours

Continuing Education: <u>online only;</u> <u>Sometime in 2020</u> (maybe). ALL C.E. offerings are approved by DSHS. See: www.assurance - quality.com/ceu.html

RN's, LPN's, NA-C's and LTC Workers would still need to take Dementia, Level 1 Training; and / or Mental Health, Level 1 Training; and / or Developmental Disabilities Administration Specialty Training, if interacting with those client categories.

NA-C's and LTC Workers would still have to take Nurse Delegation Core Training if needing to be Nurse (RN) Delegated for certain tasks (including passing medications).

NA-C's and LTC Workers would also still need to take Nurse Delegation; Special Focus on Diabetes Training if needing to be Nurse (RN) Delegated to administer Insulin Injections to clients.

Active NA-C (Nursing Assistant-Certified) licenses (for NA-C's);

Active NA-R (Nursing Assistant-Registered) licenses (for those eligible to have them); or

Active HM-C (Home Care Aide-Certified) licenses (for LTC Workers) are required, for Nurse Delegation to be able to occur.
